Detox (3-5 days): This medically managed, sub-acute program safely eliminates toxic substances from the body

Co-occurring Disorders (up to 28 days): Livengrin can stabilize and identify substance abuse and mental health disorders including depression, anxiety, trauma, and others

Residential & Partial Programs (up to 28 days):
Led by a highly experienced clinical team, Livengrin creates a safe, secure environment providing individualized patient treatment and modern facilities on a beautiful 44 acre wooded Bucks County campus

x

Specialty Programs at Livengrin:
Nurses Lifeline is a residential program for nurses and other medical personnel to address their own substance use, and resulting licensure issues.

x

First Responders Addiction Treatment (FRAT) Program for police, fire, EMS, corrections, and military personnel (active duty and veterans)

x

Livengrin offers certified DUI evaluation, education, intervention, and treatment services for county agencies

x

Patient Care Coordinators: Each patient is assigned a patient care coordinator who supports with legal, financial, housing, and other non-clinical issues

x

Medication Assisted Treatment (MAT): Naltrexone, in oral and injectable form (Vivitrol), is available to all active patients who qualify

x

Family Support (Free): Day of Enlightenment (DOE) and Parent Group are open to the public and require no registration
